ORDINANCE No. 56/2024

RECTOR OF RZESZOW UNIVERSITY OF TECHNOLOGY

of 18 June 2024

on fees for the use of accommodation in student dormitories of Rzeszow University of Technology in the academic year 2024/2025.

Pursuant to Article 95(2) of the Act of 20 July 2018. Law on Higher Education and science (Journal of Laws of 2023, item 742, as amended), after consulting the Student Government of Rzeszow University of Technology and the Doctoral Student Government of Rzeszow University of Technology, I hereby order as follows:

§ 1

The amount of fees for the use of a place/room/residential segment, accommodation in rooms adapted for people with disabilities, accommodation in guest rooms/segments and ad hoc accommodation in student rooms

in student dormitories of Rzeszow University of Technology in the academic year 2024/2025.

§ 2

1. Fees for permanent accommodation and overnight stays in AKAPIT and PINGWIN student dormitories:

- 1) permanent accommodation in a single room PLN 650.00 per month + fees for utility consumption (costs: water consumption and sewage disposal, cold water heating) and central heating consumption, electricity consumption) from 1 person;
- 2) permanent accommodation for 2 people in a double room PLN 550.00 per month + fees for utility consumption (costs: water consumption and sewage disposal, cold water heating and central heating consumption, electricity consumption) from 1 person;
- 3) permanent accommodation for 1 person in a double room PLN 800.00 per month + fees for utility consumption (costs: water consumption and sewage disposal, cold water heating and central heating consumption, electricity consumption) from 1 person;
- 4) permanent accommodation for 2 people in the residential segment for 2 people PLN 700.00 per month + fees for the consumption of utilities (costs of: water consumption and sewage disposal, cold water heating and central heating consumption, electricity consumption) from 1 person;
- 5) permanent accommodation for 1 person in the 2-person residential segment PLN 1000.00 per month + fees for utility consumption (costs: water consumption and sewage disposal, cold water heating and central heating consumption, electricity consumption) from 1 person;

- 6) permanent accommodation of 2 people with a disability certificate in a residential segment adapted for people with disabilities (1 bedroom for 2 people, living room, kitchenette, bathroom with shower and toilet), floor: ground floor; building without architectural barriers PLN 600.00 per month + fees for the consumption of utilities (costs: water consumption and sewage disposal, cold water heating and central heating consumption, electricity consumption) from 1 person;
- 7) accommodation of 1 person with a disability certificate in the residential segment adapted for people with disabilities (1 bedroom for 2 people, living room, kitchenette, bathroom with shower and toilet), floor: ground floor; building without architectural barriers PLN 1000.00 per month + fees for utility consumption (costs: water consumption and sewage disposal, cold water heating and central heating consumption, electricity consumption);
- 8) accommodation of a mother (student/doctoral student of Rzeszow University of Technology) with her child or father (student/doctoral student of Rzeszow University of Technology) with a child in a 2-room residential segment PLN 1100.00 + fees for utility consumption (costs: water consumption and sewage disposal, cold water heating and central heating consumption, electricity consumption);
- 9) accommodation of parents (students/doctoral students of Rzeszow University of Technology) with a child in a 2-room residential segment PLN 1400.00 + fees for utility consumption (costs: water consumption and sewage disposal, cold water heating and central heating consumption, electricity consumption);
- 10) daily use of the guest segment by 1 person PLN 200.00 per 1 day;
- 11) daily use of the guest segment by 2 people PLN 120.00 per 1 person for 1 day.

2. Fees for permanent accommodation in the ALCHEMIK student dormitory:

- 1) permanent accommodation in a 3-person room PLN 540.00 per month for 1 person;
- 2) permanent accommodation in a double room PLN 600.00 per month for 1 person;
- 3) permanent accommodation in a single room PLN 650.00 per month for 1 person;
- 4) permanent accommodation for 2 people in a 3-person room PLN 750.00 per month for 1 person;
- 5) permanent accommodation for 1 person in a 3-person room PLN 860.00 per month from person;
- 6) permanent accommodation for 1 person in a double room PLN 800.00 per month from 1 person;
- 7) permanent accommodation of a person with a disability certificate in a single room in a residential segment with a kitchenette, bathroom and toilet, adapted for people with disabilities, floor: ground floor, building without architectural barriers PLN 900.00 per month.

3. Fees for permanent and daily accommodation in the IKAR student dormitory:

- 1) permanent accommodation in a 3-person room PLN 520.00 per month for 1 person;
- 2) permanent accommodation in a large double room PLN 680.00 per month for 1 person;
- 3) permanent accommodation in a standard 2-person room PLN 600.00 per month from 1 person;
- 4) permanent accommodation for 2 people in a 3-person room PLN 680.00 per month for 1 person;
- 5) permanent accommodation for 1 person in a 3-person room PLN 860.00 per month from 1 person;
- 6) permanent accommodation for 1 person in a large double room PLN 860.00 per month for 1 person;
- 7) permanent accommodation for 1 person in a standard double room PLN 750.00 per month for 1 person;
- 8) accommodation of a person with a disability certificate in a single room with a kitchenette, bathroom and toilet accessible from the corridor, adapted for people with disabilities, floor: ground floor, building without architectural barriers PLN 900.00 per month per 1 person;
- 9) daily accommodation in a 2-room guest segment for 2 people PLN 100.00 for 1 day per 1 person;
- 10) daily accommodation in a 2-room guest segment for 1 person PLN 180.00 for 1 day.

4. Fees for permanent accommodation in the PROMIEN student dormitory:

- 1) permanent accommodation in a large double room of a higher standard PLN 700.00 per month for 1 person;
- 2) permanent accommodation for 1 person in a large double room of a higher standard PLN 900.00 per month for 1 person.

5. Fees for permanent accommodation in the NESTOR student dormitory:

- 1) permanent accommodation in a 3-person room PLN 500.00 per month for 1 person;
- 2) permanent accommodation in a large double room PLN 650.00 per month for 1 person;
- 3) permanent accommodation for 2 people in a 3-person room PLN 650.00 per month for 1 person;
- 4) permanent accommodation for 1 person in a 3-person room PLN 850.00 per month for 1 person;

- 5) permanent accommodation for 1 person in a large double room PLN 850.00 per month for 1 person;
- 6) permanent accommodation of a person with a disability certificate in the room 1-person apartment with a kitchenette, bathroom and toilet, adapted for people with disabilities, floor: ground floor, building without architectural barriers PLN 900.00 per month per 1 person.
- 1. Permanent accommodation for persons who do not have the status of a student/doctoral student of Rzeszow University of Technology, i.e. participants of the Polish language course at Rzeszow University of Technology, students and doctoral students of full-time and part-time studies at other Universities, graduates of Rzeszow University of Technology and other persons (including employees of Rzeszow University of Technology) in student dormitories AKAPIT, ALCHEMIK, IKAR, NESTOR, PINGWIN and PROMIEŃ, is set in the amount as in sections 1-5, increased by PLN 200.00. VAT of 8% is added to the fee.
- 2. The fees indicated in paragraph 6 above do not apply to employees of Rzeszow University of Technology living in student dormitories ALCHEMIK, AKAPIT, PINGWIN and NESTOR on the basis of concluded lease agreements for residential segments/apartments, for which separate rental price lists for residential segments/apartments apply.

§ 3

- 1. A fee for emergency accommodation is established in all student dormitories in student rooms for full-time and part-time students and doctoral students of the Rzeszow University of Technology in the amount of PLN 60.00 per 1 day.
- 2. Accommodation provided to students and doctoral students of Rzeszow University of Technology is exempt from value added tax.
- 3. Emergency accommodation in student rooms for full-time and part-time students and doctoral students of other Universities, graduates of Rzeszow University of Technology and other persons (including employees of Rzeszow University of Technology) in the amount of PLN 80.00 per 1 night per 1 person + 8% VAT.
- 4. Emergency accommodation in student rooms for organized groups PLN 100.00 per 1 night per 1 person + 8% VAT.

§ 4

- 1. In the academic year 2024/2025, the amount of the reservation fee is determined:
 - 1) for first-year students of first-cycle studies who received a place/room in a student dormitory PLN 700;
 - 2) for other full-time and part-time students of the first and second degree studies and doctoral students, in the amount equal to 1 month's fee for a place/room/residential

segment in the student dormitory in which the place/room/residential segment has been allocated and reserved.

- 2. Deadlines for payment of the reservation fee:
- 1) students of the first year of full-time first-cycle studies who received a place/room in a student dormitory during basic recruitment until 31.08.2024;
- 2) students of the first year of full-time first-cycle studies who received a place/room in a student dormitory during additional recruitment until 27.09.2024;
 - 3) other full-time first- and second-cycle students and doctoral students until 31.07.2024.
- 3. Failure to pay the reservation fee within the deadlines specified in §4 section 2 will result in the loss of the allocated and reserved place in the student dormitory.

4. Reservation fee paid:

- 1) is credited towards the fee for the first month of accommodation in a student dormitory in the case of accommodation in a student dormitory;
- 2) is refundable within 14 days from the date of resignation from the allocated place/room in the student dormitory along with sending an application for a refund of the reservation fee. The resignation and the application for a refund of the reservation fee should be submitted in writing or electronically to the e-mail address of the administration of the student dormitory where the place/room was allocated. In the application for the refund of the reservation fee, the name of the bank and the account number to which the reservation fee should be refunded must be provided. Refund of the reservation fee for first-year full-time first-cycle students who received a place/room in a student dormitory during the basic recruitment process is possible if the resignation from the allocated place/room along with the application for its return takes place by 31.08.2024. A refund of the reservation fee for other students/doctoral students who have received a place/room in a student dormitory is possible if the resignation from the allocated place/room along with the application for its refund takes place by 31.07.2024.
- 3) lack of accommodation in a student dormitory until 30.09.2024 is tantamount to with resignation from the allocated place and the lack of possibility of reimbursement of the reservation fee;
- 4) the reservation fee is not refundable in the event of resignation from the allocated place in the student dormitory or submitting an application for its refund beyond the deadlines specified in paragraph 2);
- 5. In the case of a refund of the reservation fee to a bank account maintained in a bank abroad or in a foreign currency, the costs of currency conversion and bank fees are borne by the owner of the account to which the refund is made.

6. In the case where the costs of accommodation in a student dormitory are borne by an organizational unit of Rzeszow University of Technology, sections 1-5 do not apply.

§ 5

- 1. In the academic year 2024/2025, a refundable deposit for the use of the from a place/room/residential segment in a student dormitory.
 - 1) for students and doctoral students of the Rzeszow University of Technology PLN 1000.00.
 - 2) for ERASMUS students 250.00 € or 250.00 \$.
 - 3) for other residents of student dormitories, including participants of the Polish language course at the Rzeszow University of Technology PLN 1500.00.
- 2. The refundable deposit should be paid no later than on the day of check-in in the dormitory. Presentation of the confirmation of payment of the refundable deposit is the basis for concluding an agreement specifying the conditions of accommodation in a student dormitory or a lease agreement for a place/room/residential segment in a student dormitory.
- 3. The refundable deposit is intended to cover possible losses caused by damage or loss of property in the student dormitory or to cover the overdue amount due for a place/room/residential segment in the student dormitory or to cover the costs of unjustified triggering of the fire alarm and the arrival of the fire brigade(s).
- 4. Where the refundable deposit is not sufficient to cover the costs referred to in point (a) of the in paragraph 3 or other resulting from non-compliance with the Regulations of student dormitories, the resident of the student dormitory is obliged to immediately pay the missing amount.

§ 6

- 1. Fees charged for damages, destructions and deficiencies in the equipment of a room/residential segment and for the use of the laundry room in the student dormitory:
 - 1) for unjustified triggering of a fire alarm. PLN 200.00 for the arrival of 1 fire brigade;
 - 2) for damage, breaking glass in EPR PLN 100.00;
 - 3) for damage to the fire detector or a speaker of the DSO sound system PLN 500.00;
 - 4) for destruction, breaking fireproof glass in fire doors PLN 500.00 per 1 m2 of glass;
 - 5) for losing, destroying and making a new key to a room/residential segment in the dormitory ALCHEMIK, AKAPIT i PINGWIN PLN 120.00;
 - 6) for losing, destroying and making a new key to a room/residential segment in the dormitory IKAR, NESTOR, PROMIEŃ 250.00 PLN;
 - 7) for destruction, damage or loss of the Mifare entry card PLN 100.00;

- 8) for damage, lack of a blanket during check-out PLN 150.00;
- 9) for damage, lack of a quilt during check-out PLN 200.00;
- 10) for damage, lack of a pillow during check-out PLN 150.00;
- 11) for damage, lack of duvet cover, pillowcase or sheet PLN 100.00 / 1 piece;
- 12) for damage, lack of curtain PLN 200.00 / 1 piece;
- 13) for damage, lack of curtain PLN 200.00 / 1 piece;
- 14) for damage, lack of window blind PLN 300.00 / 1 piece;
- 15) for destruction, damage to a washbasin faucet PLN 200.00;
- 16) for destruction, damage to the sink faucet PLN 300.00;
- 17) for destruction, damage to a standard shower faucet PLN 600.00;
- 18) for destruction, damage to a shower faucet with a rain shower PLN 1000.00;
- 19) for destruction, damage to a door closer with a sliding rail PLN 300.00;
- 20) for destruction, damage to the arm door closer PLN 200.00;
- 21) for destruction, damage to the entrance door leaf, lock insert to a segment or a living room according to the actual value on the day of its destruction or damage;
- 22) for destruction, damage to an induction hob according to the actual value on the day of its destruction or damage;
- 23) for destruction, damage to a microwave oven according to the actual value on the day of its destruction or damage;
- 24) for destruction, damage to a washbasin, sink according to the actual value on the day of its destruction or damage;
- 25) fee for using an automatic washing machine PLN 4.00 / 1 washing cycle lasting max. 60 minutes;
- 26) fee for the use of an automatic dryer PLN 4.00 / 1 drying cycle lasting max. 60 minutes.

§ 7

In matters not regulated by this Ordinance, the provisions of the Civil Code shall apply.

§ 8

The ordinance enters into force on the date of signing.
